## What is this product?

#### Type

This product is a share of an investment company qualifying as an undertaking for collective investment in transferable securities (UCITS).

#### Term

This sub-fund has no maturity date. However, the board of directors may decide to close the sub-fund under certain circumstances.

#### Objectives

The sub-fund aims to preserve the shareholder's capital while achieving long-term capital growth and best risk adjusted returns by implementing an investment strategy consisting in a direct and/or indirect long exposure to financial markets. The sub-fund also aims to minimize the volatility of its portfolio.

Based on the management company's expectations of the evolution of the economic and market conditions, the sub-fund flexibly and dynamically invests in equities (up to 100% of the net assets but emerging market exposure is limited to 25% of the net assets), bonds (up to 100% of the net assets but investments in unrated bonds and/or in bonds with a rating below investment grade is limited to 20% of the net assets and investments in convertible bonds is limited to 10% of the net assets), money market instruments (up to 25% of the net assets), investment funds and exchange traded funds (up to 100% of the net assets), exchange traded notes and/or exchange traded commodities (up to 20% of the net assets) with no restriction in terms of sector. The percentage of the portfolio invested in these different instruments may vary depending on the valuation of the various asset classes ("bottom-up approach") and the market situation based on fundamental analysis of the global macroeconomic environment and of its indicators (e.g., growth, inflation, public deficits, etc.) ("top down approach"). The sub-fund's portfolio may be positioned defensively if the management company expects the financial markets to evolve negatively.

The sub-fund mainly invests in securities denominated in euro (EUR), US dollars (USD), Swiss francs (CHF), Danish krone (DKK), Swedish krona (SEK) and/or in pounds sterling (GBP).

The sub-fund may use all types of financial derivative instruments for hedging and investment purposes.

**Benchmark:** The portfolio is actively managed on a discretionary basis without reference to a benchmark.

#### Intended retail investor

This product is designed for investors who are willing to achieve income and capital growth and have a medium to long term horizon. The investor can bear losses up to the invested amount. This product is appropriate for investors with a basic to advanced knowledge and experience of the product and the global equity markets.

#### Other information

**Depositary:** Banque de Luxembourg

**Dividend income:** This class is a capitalisation class meaning that income is reinvested.

**Conversion right:** The investor has the right to convert his investment in shares of one sub-fund into shares of the same sub-fund or another sub-fund. The investor can obtain information about how to convert in the prospectus of the fund.

**Segregation:** The assets and liabilities of a sub-fund are segregated pursuant to the law so that the commitments and liabilities of one sub-fund do not affect the other sub-funds.

## What are the risks and what could I get in return?

### Risk indicator



The summary risk indicator is a guide to the level of risk of this product compared to other products. It shows how likely it is that the product will lose money because of movements in the markets or because we are not able to pay you.

We have classified this product as 3 out of 7, which is a medium-low risk class.

This rates the potential losses from future performance at a medium-low level, and poor market conditions are unlikely to impact our capacity to pay you.

**Be aware of currency risk.** You may receive payments in a currency that differs from your reference currency, so the final return you will get depends on the exchange rate between the two currencies. This risk is not considered in the indicator shown above.

The sub-fund is also exposed to the following materially relevant risks that are not included in the summary risk indicator: Concentration risk. Other risk factors might exist.

## What happens if European Capital Partners (Luxembourg) S.A. is unable to pay out?

If we are not able to pay you out what we owe you, you are not covered by any national compensation or guarantee scheme. To protect you, the assets are held with a separate company, the depositary Banque de Luxembourg. Should we default, the investments are liquidated and the proceeds are distributed to the investors. In the worst case, however, you could lose your entire investment.

## What are the costs?

### Costs over time

The tables show the amounts that are taken from your investment to cover different types of costs. These amounts depend on how much you invest, how long you hold the product and how well the product does. We have assumed:

- In the first year you would get back the amount that you invested (0% annual return). For the other holding period we have assumed the product performs as shown in the moderate scenario
- 10,000 EUR is invested
